An Accident Review Board (ARB) was convened on July 1, 2009, to review the safety investigation report of the Dutch Creek Tree Felling Fatality.

A co-lead Forest Service and National Park Service Safety Investigation Team conducted the investigation and presented the Factual Report and Management Evaluation Report to the ARB. The reports were reviewed and approved with some revision. A Safety Action Plan (SAP) was developed by the ARB with a focus on key items that, when implemented, could help prevent similar mishaps in the future. We approve the ARB's recommendations.

Please review the enclosed SAP and take appropriate steps to ensure completion of each respective action by the assigned date. The Forest Service's Office of Safety and Occupational Health should be notified as each item is completed.

Subject: Accident Review Board Letter of Transmittal - Dutch Creek Tree Felling Fatality

To: Chief, U.S. Forest Service and Director, National Park Service

On July 25, 2008, a firefighter, working the Iron Complex Fire, died as the result of a tree felling incident. A safety investigation team, co-lead by the Forest Service and National Park Service, was dispatched to investigate the accident. The team's Factual Report and Management Evaluation Report were presented to the Accident Review Board (ARB) and were accepted with some revision.

The Accident Review Board (ARB) has recommended corrective measures to help prevent similar accidents from recurring in the future. Please review and approve the enclosed Safety Action Plan (SAP) and letter.

**Recommendation 01 – Propose to the Fire Executive Council (FEC) to require the implementation of an incident-within-an-incident plan for Incident Management Teams (IMT) to include a risk assessment process.**

Responsible Unit: Fire Executive Council

**Recommendation 02 – Propose to the FEC for the development of a planning protocol designed to integrate incident management operations into local/county/state/region emergency services systems.**

**Recommendation 03 – Propose to the FEC for the development of rescue operations training competencies, to include medical evacuation (air/ground), for incident management operations with a focus on the management of emergency response for incident personnel.**

**Recommendation 04 – Propose to the FEC to append the current medical plan section (Incident Command System Form ICS 206) that each incident action plan shall identify procedures for medical emergency, rescue and evacuation. This should include the addition of a risk assessment of resources (air/ground), emergency operations, identification of resources, location, capabilities and contact information.**

**Recommendation 05 – Propose to the FEC the affirmation of the use of trainees in staff/line fire assignments only when direct supervisory requirements are met. In the interim, the Forest Service and National Park Service shall issue direction that prohibits the assignment of trainees in staff/line fire assignments without the requisite supervisory oversight.**
